§ 1 Contract conclusion

In the web shop you can add the trainings and services you would like to purchase to your shopping cart by clicking on the button. To place an order, you must log in with your user account. The presentation of the services in the web shop does not constitute a legally binding offer but is an invitation to submit an offer (invitatio ad offerendum). From there you will be guided through the rest of the ordering process. In the last step of the checkout process, you can review all the contents of the current purchase as well as the terms and conditions applicable to the services. Until you place your order by clicking on the button “book now with obligation to pay”, you can correct input errors in the contents of your shopping cart or cancel the ordering process as follows:

- ▶ You can change the quantity of items in your cart by adjusting the desired quantity.
- ▶ You can remove items from your shopping cart by clicking the “trash can” icon with the corresponding item.
- ▶ You can cancel the order process by closing the browser window or by clicking the “shopping cart” button and removing all items.

By clicking the button “book now with obligation to pay” in the last step of the ordering process, you make a binding offer to purchase the products and services listed in the order overview. Immediately after submitting the purchase offer by clicking on the button “book now with obligation to pay”, you will see either a purchase confirmation or an error message on the web shop page (meaning your purchase offer was not accepted).

A contract between you and Rohde & Schwarz Networks and Cybersecurity GmbH is concluded (i) as soon as Rohde & Schwarz Networks and Cybersecurity GmbH accepts your offer to purchase by displaying a purchase confirmation in the web shop, (ii) upon provision of or access to the respective service, or (iii) with a separate e-mail containing an express purchase confirmation (depending on what happens first). If you see a website with an explicit error message, no contract has been concluded. In such a case, you can contact Rohde & Schwarz Networks and Cybersecurity GmbH for further assistance.

§ 2 Withdrawal

You can cancel your participation free of charge up to 14 days before the start of the training or examination at the latest. This must be done in writing (e-mail is sufficient). In case of cancellation after this date, we will charge a cancellation fee of EUR 100.00 (excl. VAT) per workshop day and EUR 50.00 (excl. VAT) per certification. For web-based training courses, the right to cancellation expires once the course begins. Before the start of the training, we offer you the possibility of a free rebooking to another participant. Please let us know the name and contact details of the new participant in time. For events where the provision of the devices used in the workshop is part of the price, the following additional regulations apply: in the case of cancellation, the participant has no entitlement to the device that was to be included in course participation.

§ 3 Cancellation of training courses by Rohde & Schwarz Networks and Cybersecurity GmbH

Please understand that we may have to cancel courses should the trainer become unavailable or if the number of participants is too low. We will always endeavor to inform you of this as soon as possible. Should we be forced to cancel a training course, any participation fees paid will be refunded to you immediately.
